- 8. Filling up of the post is at the discretion of Management based on suitably of candidates. The management in all matters relating to eligibility, acceptance or rejection of the application, made be final and management will not entertain any enquiry or correspondence in this regard.
- The candidates working in Government / Semi Government or PSU Organization shall have to produce "NO OBJECTION CERTIFICATE" from the concerned organization at the time of Online Test / Interview as the case may be, failing which their candidature will be disqualified.

For VSJE Electrical:- One Leg (OL) & Hearing Handicapped (HH), For VSJE – Civil: One arm (OA), One Leg (OL) & Hearing Handicapped (HH), Physically Handicapped candidates can apply and shall have to submit Certificate of Civil Surgeon, indicating existing Percentage of disability.
