<b>Qualification &amp; Experience</b>	First Class Diploma in Engineering in Chemical / Mechanical / Electrical / Instrument Technology (Full time course) with 60% marks. [Final Year Diploma students and those awaiting results are <b>not</b> eligible to apply] Desirable: One year post qualification experience in a Refining / Petroleum / Power / Chemical / Lube / Petrochemical / Fertilizer Industry OR One year apprenticeship training under the Apprentices Act in a Refining / Petroleum / Power / Chemical / Lube / Petrochemical / Fertilizer Industry.		
<b>Age limit</b>	Not exceeding 30 years as on 01.02.2015.		
<b>Scale of Pay</b>	Rs. 12500 - 22000. In addition to basic pay, candidates selected will be entitled for DA, HRA, PF, Gratuity and other benefits as per Corporation rules. Total Cost to Company at the minimum of the scale will be Rs. 5.51 lakhs per annum (approx).		
<b>Reservation</b>	Out of the above 71 posts, 7 posts are reserved for SC, 1 post for ST and 17 posts for OBC candidates. One post each is reserved for Hearing Handicapped and Orthopedically Handicapped candidates meeting the minimum criteria. (For Hearing / Orthopedically handicapped candidates, age is relaxable by 10 years and degree of disability should be minimum 40%).		

**Selection:**

The selection methodology will comprise of written test and interview. The candidates short-listed in the written test will be required to appear for Interview for final selection. Appointment will be subject to the selected candidates clearing the medical examination.

**Medical Standards:**

Candidates provisionally selected by BPCL will have to undergo a pre-employment medical examination before joining. The health of each candidate will be assessed by the Corporation's Authorized Medical Officers / nominated hospitals and the appointment will be subject to meeting the medical standards prescribed by the Corporation.

- Myopia & Hypermetropia (vision), if any, should be within permissible limits.
- Colour blindness or squint, partial or full, is not acceptable in any case.
- Night blindness and Glaucoma is also not acceptable.
- Noise induced hearing loss and bilateral hearing loss shall be considered a disqualification.
- Any other major medical ailment will debar a candidate from being eligible for the job.

Candidates selected under PWD category, except the handicap for which relaxation is acceptable, must be within the stipulated normal range of all other physical standards. PWD candidates would be required to furnish valid Disability Certificate duly stamped and signed by a medical panel empowered for the purpose and should comprise of three medical practitioners.

The mentioned medical standards are only indicative and not exhaustive.

The decision on medical fitness by the Corporation's Authorized Medical Officers / nominated hospitals would be final and binding on all candidates. No correspondence or queries in this regard shall be entertained by BPCL.

**General Information and Conditions:**

1) Centre for Written test will be at Kochi. 2) Wherever CGPA/OGPA or Letter Grade in Diploma is awarded, equivalent percentage marks should be provided in the on-line application as per norms adopted by the University / Institute. 3) Reservations / Relaxations / Concessions for SC / ST / OBC / PWD / Ex-servicemen will be as per Government directives. 4) Persons employed with Government or Semi-Government Organizations / Public Sector Undertakings MUST submit NOC at the time of Interview. 5) Engineering graduates are not eligible to apply. 6) SC / ST / PWD candidates attending interview are eligible for to and fro II class train / bus fare, by the shortest route, from the nearest railway station to Ernakulam, on submission of original tickets, as per rules. 7) Everything else being equal, preference will be given to erstwhile Kochi Refinery Project Evictees. 8) The Management reserves the right to fill or not to fill all or any of the above positions without assigning any reason whatsoever. 9) OBC category candidates should submit copy of caste certificate dated on or after 01.02.2015 from the Tahsildar or other competent authority approved by the Government of India (Ref. W.R. No. 12011/68/93/BCC (C) dated 10<sup>th</sup> September 1993) certifying that they do not belong to the "creamy layer" of the OBC community as per the proforma of Government of India at the time of Interview. 10) The job involves working in rotating shifts. 11) Only male candidates need to apply. 12) First class with 60% marks for Diploma Examination is relaxed to 50% marks for SC / ST / OH / HH candidates. 13) Those candidates domiciled in the State of Jammu & Kashmir between 01.01.1980 and 31.12.1989 will be allowed 5 years relaxation in upper age limit. 14) Persons with disabilities can also apply for the above posts in accordance with provision of para 25 of DOP & T OM No.36035/3/2004 – Estt. (Res) dated 29/12/2005. 15) Posting shall initially be at Kochi and the services are transferable anywhere in India as required by the Corporation. 16) The tentative date of the written test will be during last week of March 2015.

**Right to restrict candidates:**

The Management reserves the right to call for test / interview only those who, in its opinion, are likely to be suitable. Management may at its discretion, raise / relax the eligibility standard to restrict the number of candidates or to make available sufficient number of candidates to be called for written test / interview.
