2: The persons with disabilities, Ex-servicemen & Sports person shall claim the vacancies reserved for the categories to which they belong.

Mode of Application.

1. A candidate may apply in any Revenue District of the State irrespective of his/ her home Revenue District subject to condition that he/ she shall apply in respect of one Revenue District only.
2. The candidate shall have to furnish an affidavit/ undertaking to the effect that he/ she has not made application for engagement of Sikhya Sahayak in any one Revenue District other than the Revenue District applied for. If, on verification it is found that the candidate has applied in more than one Revenue District for engagement as Sikhya Sahayak, his/ her applications shall be rejected without assigning any reason thereof. In submission of defective affidavit / undertaking, the application shall also liable to be rejected.

3. The candidates shall have to furnish a copy of the employment exchange registration card to the effect that she/ he has registered her /his name in any employment exchange in the state at the time of verification of certificate.

Eligibility

For the post of +2 Arts/ Com CT & +2 Science CT

- a) Higher Secondary (+2 or its equivalent) with at least 50% marks and 2 year Diploma in Education (CT)

OR

Higher Secondary (+2 or its equivalent) with at least 50% marks and 2 year Diploma in Education (Special Education)

OR

Graduation and 2 year Diploma in Elementary Education / 2 year Diploma in Special Education

And

- b) Pass in the Odisha Teacher Eligibility Test (OTET – Category – I)
c) Candidates must have Odia as MIL up to Class – VII or pass in Odia language test equivalent to ME standards conducted or declared by BSE (O).

For the post of B.A. B.Ed. & B.Sc. B.Ed.

- a) Graduation with at least 50% marks and 1- year Bachelor in Education (B.Ed.)

Or,

Graduation with 50% marks and 1 year B.Ed. (Special Education)

Or,

Higher Secondary (+2 or its equivalent) with at least 50% marks and 4 year B.A. B.Ed. /B.Sc. B.Ed.

- b) Pass in the Odisha Teacher Eligibility Test (OTET – Category –II)

- c) Candidates must have Odia as MIL up to Class – X.

(I) That, engagement of all Sikshya Sahayak (SSs) will be made by the Collector under each category i.e. Trained graduate Science, Trained Graduate Arts (Social Science), Trained Graduate Arts (Language) under the Programme of Sarva Sikshya Abhiyan (SSA) and for implementation of the said Act, TGT (Science) will mean TGT (Physics, Chemistry & Mathematics) or TGT (CBZ/ Life Science) , TGT Social Science will mean TGT (Arts) having any two (2) of the optional subject such as History, Geography, Political Science and Economics and TGT (Language) will mean TGT (Arts) having Odia or English as one of the

reduction of 5% in minimum qualifying marks in Higher Secondary (+2) or in any other case may be, shall be allowed to the candidates belonging to SC, ST

- (iii) Provided that if trained candidates having the above percentage of marks in Higher Secondary (+2) or in graduation level, as the case may be, are not available and posts remained unfilled, trained candidates having the minimum percentage of marks prescribed at the time of admission in teacher education with OTET pass shall also be considered for engagement.
- (iv) The candidates having requisite academic qualification without training qualification with OTET pass may be considered for engagement only on the basis of qualification so relaxed by the Central Government with the stipulation that such untrained candidates will acquire training qualification within the stipulated date given by the Central Government.
- (v) The untrained candidates having the requisite academic qualification required for teacher's training courses as decided by NCTE from time to time and passing of OTET may only be eligible for engagement.
- (vi) For the purpose of degree in teacher education (B.Ed.) B.Ed. degree of other Universities declared equivalent with corresponding degree of the universities of Odisha and a course recognized by the NCTE shall be considered.
- (vi) Untrained candidates selected as per the relaxed standard shall have to furnish an affidavit at the time of engagement to the effect that they shall acquire the required training qualification within the stipulated period in accordance with the provisions of the Act or as decided by the Government of India from time to time. Candidates unable to acquire the training qualification within the stipulated period shall be disengaged automatically.
- (vii) Candidates who are in service shall furnish the copy of the no objection certificate issued by the employer at the time of joining.

Age

Candidates shall not be below 18 years of age and above 35 years of age as on 01.01.2015. In case of SC/ST, Women, Ex-servicemen & SEBC candidates the upper age limit may be relaxed by five years and in case of PH candidates the upper age limit may be relaxed by 10 years.

Reservation

- (a) The Orissa Reservation Vacancies (in posts and services for ST & SC) Act, 1975 and rules made there under and such other principles of reservation as prescribed by the State Government from time to time shall be followed up.
- (b) 33% (1/3) of the posts of SS will be reserved for women candidates of respective categories. Similarly 3% will be reserved for Physically Handicapped (as per provision of Section – 33) of ("THE PERSONS WITH DISABILITIES) (EQUAL OPPERTUNITIES, PROTECTION OF RIGHTS AND FULL PARTICIPATION) ACT, 1995, 1% for eminent sports personnel and 3 % for Ex-Servicemen. These reservations are applicable to each category like SC, ST, SEBC & General and not on the basis of overall percentage. Instructions contained in G.A. Deptt. Resolution No. 25384 dtd. 20.09.2005 and instructions thereof shall be followed up.

Other

- (i) The select will be valid for a period of One (1) year from the date of its final publication.
- (ii) The application should be superscribed as **Application for the post of _____** on the top of the envelope.
