RECRUITMENT FOR THE POST OF POLICE CONSTABLE (EXECUTIVE) IN ANDAMAN AND NICOBAR POLICE

Applications are invited from the eligible candidates in the prescribed format for filling up the vacant posts of Police Constable (Executive) in Andaman & Nicobar Police. The details of vacant posts, scales of pay and eligibility conditions are given below:-

*** Note:-** The candidates who had already submitted their candidature for the above said post vide recruitment notice published in "The Daily Telegram" on 18/08/2015, need not to apply fresh application as their earlier application will be considered.

The candidates who qualify the above mentioned minimum physical standards shall undergo a physical endurance test.

(iii) Physical Endurance Test

The candidates, who fail to qualify the Physical Endurance Test, will be eliminated at that stage itself from the selection process.

The candidates should bring their original certificates of educational qualification, age proof & category certificate at the time of Physical Measurement (PM)/Physical Endurance Test (PET) for verification.

2. WRITTEN EXAMINATION (300 MARKS)

The candidates, who qualify in Physical Measurement (PM)/Physical Endurance Test (PET) shall be put through the written examination. The paper will be both in English and Hindi. The candidates can opt answering in either language except for the portion of language paper, which will contain questions on Hindi and English both.

The question papers(s) will cover general knowledge, reasoning, simple arithmetic, test on language Hindi & English including comprehension, general aptitude and any other topic to check the eligibility of the candidates etc.

Only those candidates who obtain 40% or more marks will be considered qualified in the written test.

The final list of the selected candidates, in order of merit, will be prepared by adding the aggregate scores obtained by candidates in the written test. The list of selected candidates shall be declared based on merit and number of vacancies notified/existing.

4. MEDICAL EXAMINATION

Successful candidates shall be subjected to medical examination as given below:

- i) Minimum distant vision should be 6/6 and 6/9 of two eyes without correction i.e. without wearing of glasses. The candidate should not have Colour Blindness.
- ii) The candidate must not have knock knee, flat feet, varicose vein or squint eyes, bow legs, inability to flex the fingers properly or any other obvious deformities.
- iii) The candidates must be in good mental and physical health and free from any physical defects likely to interfere with the efficient performance of Police duties.
- iv) Every candidate shall have to go through a medical examination by GB Pant Hospital Port Blair before appointment.

5. HOW TO APPLY

- (i) Candidates may submit their applications in a prescribed format given below along with the self attested copies of certificates of educational qualification, age proof, OBC/ST category with three passport size photographs (one should be affixed in the space given in the application form and other two should be attached along with application form) **to the Dy. Superintendent of Police (HQ), Police Head Quarter, Atlanta Point, Port Blair on any working day with effect from 29/02/2016.**
- (ii) The submission of any fake/forged document shall entail the registration of a criminal case against the candidate in accordance with law besides cancellation of candidature.

6. CLOSING DATE

Application form should be submitted to the Dy. Superintendent of Police (HQ), Atlanta Point, Port Blair latest **by 1700 hrs on 29/02/2016**.

7. INSTRUCTIONS IN GENERAL

- i) After scrutiny and acceptance of the application forms, each applicant will be issued an Admit card which will be required at all stages of the recruitment process. **The Admit card should be collected by the candidate from 21/03/2016 to 31/03/2016 from Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair.**
- ii) **Benefit of OBC/ST would be given only to those candidates who belong to the OBC/ST category as notified by the Andaman and Nicobar Administration.**
- iii) The candidates, who fail to put a tick mark in the appropriate check box of the Application Form related to "Category" and/or fail to enclose OBC/ST Certificates will be treated as "General Candidates" and the category of such candidates shall not be subsequently changed under any circumstances.
- iv) Original documents (Educational qualifications, age proof and **OBC/ST** category) will be checked at the time of "Physical Measurement (PM)/Physical Endurance Test (PET)". The candidates, therefore, should bring these original documents/certificates only at the time of "Physical Measurement (PM)/Physical Endurance Test (PET)".
- v) Incomplete applications in any form are liable to be rejected. No further correspondence will be entertained in this regard and no Admit Card will be issued to such candidates.
- vi) Candidates failing at any stage will be eliminated at that stage itself.
- vii) The candidates shall prepare for the physical endurance test and participate at their own risk. The A&N Police will not be liable for any damages in the event of any injury or any casualty suffered by a candidate during the physical endurance test.
- viii) The candidates who are not satisfied with the decision of the Recruitment Board concerning their Physical Measurements only may prefer appeal in writing in the prescribed format to the appellate authority on the same day.
- ix) The Physical Measurement, Endurance Test, Written test will be held at Police Lines, Port Blair. The date and time shall be communicated in due course through local newspapers and AIR etc.
- x) No TA or DA will be paid to the candidates for attending the selection process or Interview.
