**Note:**

Only those candidates who possess the required qualification on or before 01.01.2016 are eligible to apply. All qualifications should be from academic/technical Institutes, recognized and approved by appropriate statutory authority.

**Selection Process:**

Eligible candidates will have to undergo two hours objective type written examination/test. Based on the performance in the written test, merit list of successful candidates for appearing in the subsequent skill test will be drawn. All such short listed candidates will have to appear for skill test.

**Training, Emoluments and Placement:**

Selected candidates will undergo training for a period of one year and will be paid a consolidated stipend of ₹ 11,500/- Per Month. After successful completion of the training they will be placed in regular establishment in the pay scale of ₹ 11,500/-3%-26000 (W3) with a starting basic pay of ₹ 11,500/-.

**Health:**

The candidates should have sound health. Before joining, candidates will have to undergo medical examination by NTPC Medical Board and the decision of the board shall be final and binding. Appointment will be subject to meeting the medical norms prescribed by the Company. No relaxation in medical norms is allowed.

**General Conditions:**

01. Selected candidates will be required to execute a service bond of ₹ 50,000/-for General/OBC and ₹ 25,000/- for SC/ST/PWD Candidates for serving the corporation for a minimum period of 3 years after completion of training period.
02. The management reserves the right to raise the minimum eligibility standards in order to restrict the number of candidates to be called for skill test if so required.
03. No interim correspondence will be entertained.
04. TA/DA will not be paid to any candidate appearing for written test.
05. Reservations and relaxation is allowed for SC/ST/OBC(Non Creamy Layer)/PWD(degree of disability 40% or above)/XSM candidates as per Govt. Directives / Rules. PWD candidates with disabilities of OL(One Leg), OA(One Arm) & HH(Hearing Handicapped) are eligible to apply in PWD category.
