- 1. The number of above vacancies may change as per requirement.
- 2. Above personnels may have to work in shift duties as per requirement, roster schedules and shift policy as applicable from time to time.
- 3. Examination Centre & Selection Process:-

Selection Processes for above posts will be based on written Test (Computer Based Test) CBT and Interview. Computer Based Test (CBT) will be held at Agra, Allahabad, Ghaziabad, Gorakhpur, Kanpur, Lucknow, Meerut, Varanasi & Greater Noida Cities. U.P. Rajya Vidyut Utpadan Nigam Ltd., however, have the right to cancel any of the Examination city/Center and/or add some another Cities/Centers depending upon the requirement, administrative feasibility, or any force-majeure conditions etc.. The test shall be of objective type of total 200 marks and shall comprise of total 200 questions, out of which 150 questions shall be from the minimum qualification level for the relevant post applied and 50 questions of General Knowledge/Awareness, Reasoning and General Hindi. Each correct answer shall carry one mark each and each wrong answer shall carry negative mark of 0.25. Candidates of Un-Reserved/OBC who obtain less than 30% marks in CBT and SC/ST candidates who obtained less than 25% marks in the CBT will not be eligible to be considered for selection. Interview carrying 20 marks will be conducted at Lucknow only. Maximum number of candidates short listed for interview will be 3 times the number of vacancies. Qualifying candidates with same marks in CBT at bottom will be counted as one for shortlisting purpose only. Appearing in the CBT and interview is compulsory; failing which candidature will be treated as cancelled. Finally, the merit list shall be prepared on the basis of the combined marks obtained in the CBT and interview.

- 4. Handicapped (OA/OL,PB,PD) candidates may apply for the post of AE (Trainee)(E&M Cadre). Candidates shall be considered in handicapped category if they are affected with above disabilities by atleast 40% or above. Candidates are advised to mention this fact specifically in the application. A certificate from Medical Board constituted by State Govt. shall have to be produced at the time of interview, failing which the candidature shall be treated as invalid and cancelled.
- 5. PAY SCALE:- Rs. 15,600.00–39,100.00, Grade pay Rs. 5400.00
  Besides the above, State Government DA, Other allowances and benefits e.g. various Leaves, LTC, Medical Treatment, CPF, Gratuity, Housing facility at Projects and various incentives etc shall also be admissible as per existing rules of U.P. Rajya Vidyut Utpadan Nigam Ltd. from time to time during training and after absorption. All the post are covered under CPF Scheme.

There may be amendment in designation and Rules & Regulations of U.P. Rajya Vidyut Utpadan Nigam Ltd. in future.

6. PLACEMENT:-

The selected candidates for the post of Assistant Engineer(Trainee) shall undergo for minimum one year training. They shall be posted at a location within the Nigam after successful completion of training. The job however is transferable and successful Candidates, during their service tenure, can be placed in any of the functions at any power station i.e. Anpara, Obra (Sonebhadra), Panki (Kanpur), Harduaganj (Aligarh) & Parichha (Jhansi)/ corporate office of the Nigam or at positions in the joint venture & subsidiary companies of UPRVUNL in accordance with the rules & regulations of UPRVUNL.

- 7. <u>BOND</u>:- The amount of Rs. 3.00 lacs for the post of Assistant Engineer for the period of 5 years shall have to be submitted at the time of joining by the candidates.
- 8. AGE LIMIT as on 01.01.2016 Minimum 21 yrs & Maximum 40 yrs. Relaxation:-
  - (a) Period of apprenticeship training or 01 year (Whichever is less) in upper age limit to the candidates who have undergone apprenticeship training under apprenticeship act 1961.
  - (b) 05 years in upper age limit to the SC/ST & OBC (Non-creamy layer) who are Original inhabitant (Domicile) of Uttar Pradesh. Candidates of these categories but not resident of Uttar Pradesh shall be treated as un-reserved (UR) for all purposes.
  - (c) 15 years in upper age limit to the handicapped candidates having 40% or above disability.

9. RESERVATION:-

- (i) A candidate must be original inhabitant (Domicile) of UP to avail the reservation benefits. Candidates of SC/ST/OBC(Non Creamy Layer)/PH but not resident of UP shall be treated as unreserved(UR) category for all purpose.
- (ii) SC/ ST & OBC (Non- Creamy Layer) candidates who are original inhabitants (Domicile) of Uttar Pradesh shall be considered for reservation under these categories as per state government rules.
- (iii) Horizontal reservation shall be applicable as per State Government rules and mentioned in Projected Vacancies tables.

10. QUALIFICATION:-

(Post Code: 01 & 2)

(a) Thorough Knowledge of Hindi in Devnagari Script. If the candidate has not passed High School or equivalent examination in Hindi, he/she has to clear the exam conducted by the Registrar, Departmental Examinations Govt. of UP, within 3 years of joining.

(b) A degree in Electrical/Mechanical/Industrial and Production Engineering from a University or Institution established by law in Uttar Pradesh

or from any other institution recognized by State Government or a degree or diploma recognized as equivalent thereto by the State Government.

OR

Degree in Examination Electrical/Mechanical/Industrial/Industrial and Production Engineering conducted by any of the Universities in India incorporated by any act of the Central/State Legislature or by UGC.

OR

Section "A" and "B" of the Associate Membership of the Institution of Engineers (India).

Note:(i)For all the above post (Post Code no. 1 & 2) Degree from distance learning education shall not be eligible.

- (ii)Candidates, appearing in final year Exams may also apply but final year marksheet & Degree/Provisional Degree for passing the final Exams must be submitted at the time of interview otherwise candidate shall not be allowed to appear in interview and their candidature shall be cancelled.
- 11. <u>NO OBJECTION CERTIFICATE</u>:- The candidates who are working with any State/ Central/ Semi Government organisation shall have to submit "No Objection Certificate" from their present employer at the time of interview, failing which they will not be permitted to appear in the interview.
